and affiliated to Odisha Nurses & Midwives Examination Board (ONMEB), Govt. of Odisha)

Applications are invited from the interested eligible candidates for GNM admission in management seats along with unfulfilled seats at NTI, Ispat General Hospital, Rourkela for the academic session 2025-26.

**1. ELIGIBILITY CRITERIA & HOW TO APPLY;**

- a) Eligibility Criteria are same as prescribed in the Prospectus for admission into different Nursing courses for the academic session 2025-26 published by DMET, Odisha. The eligible and interested candidates for seeking GNM admission in management quota at NTI, IGH, Rourkela, must apply online in the official website of Directorate of Medical Education and Training, Odisha [www.dmetodisha.gov.in](http://www.dmetodisha.gov.in) and <https://dohodisha.nic.in> for GNM course on or before **15.07.2025**.
- b) Application form & Prospectus for admission into different nursing courses for the academic session **2025-26** are available in the official website of Directorate of Medical Education and Training, Odisha [www.dmetodisha.gov.in](http://www.dmetodisha.gov.in) and <https://dohodisha.nic.in>.
- c) A copy of submitted online application along with copy of all uploaded documents as per prospectus must be submitted to The Principal, NTI, IGH, Rourkela before online choice locking option open for the applicants in [www.dmetodisha.gov.in](http://www.dmetodisha.gov.in) website.

**2. IMPORTANT INFORMATION:**

1. Management seats shall be filled up as per the Merit list of Central Counseling Committee of Govt. of Odisha.
2. First preference will be given to dependants of employees of Rourkela Steel Plant (including Odisha Group of Mines (OGM)) having Medical Treatment Book issued by the competent authority for the management seats and unfulfilled counseling seats for admission into GNM course. Candidate has to submit a copy of MTB along with application Form at NTI, IGH.
3. Vacant seats after taking admission of dependants of RSP employees (including Odisha Group of Mines) shall be filled up by other applicants.
4. Admitted students including dependants of RSP employees have no right to employment, nor any obligation to accept any employment due to nursing training.
5. Reservation Criteria will remain same for Management seats like counseling seats as prescribed in the Prospectus for admission into different Nursing courses for the academic session 2025-26 by DMET, Odisha.
6. Fee Structure, Stipend etc. will remain same as existing practice for counseling seats.
